#### 1967 - 1990

The General Directorate for Armaments (DGA) brings together about 30 French industrialists at Satory every two years.

#### 1992 - 1993

The exhibition is held for the first time at Le Bourget and takes the name of Eurosatory "European Exhibition of Land Defence Equipment". Establishment in 1993 of the COGES - Le Commissariat Général des Expositions et Salons, subsidiary of GICAT.

#### 1994 - 1996

Eurosatory becomes international with the participation of the United States, the Western European Union (WEU), the European Free Trade Association (EFTA) and Russia. The exhibition then takes the name of "International Exhibition of Defence Equipment".

#### 2000 - 2004

Eurosatory becomes the "International Exhibition of Land and Airland Defence" and moves in 2002 to the Parc des Expositions Paris Nord Villepinte.

#### 2006 - 2016

Eurosatory is the world's leading international Defence and Security exhibition. In 2016, the entire technological continuum was presented from Land and Airland Defence and Homeland Security domains. One-third of the exhibiting area was dedicated to Homeland Security and 300 companies offered solutions for Civil Security and Rescue. Strong presence of Cyber Defence and Cyber Security sectors, UAVs and international Think Tanks.

- Global representation of the Defence and Security industry. The most represented countries of the 2018 edition: France, United States, Germany, Israel






